

**Rules for Registering a Prefix:**

1. Write clearly in black or blue ink, or type.
2. The proposed prefix must not be the full name of a registered Kerry Bog Pony that has lived in the past forty (40) years.
3. The prefix applicant must not have another registered prefix on record with the Registry.
4. The Registrar can deem the prefix to be confusingly similar to a name, a prefix previously recorded, or otherwise unsuitable, and may use one of the alternative prefix choices.
5. Your prefix must be used in registration applications exactly as recorded below. **This prefix will be used for your use only. Should someone not recorded as the prefix owner with the Registry use this prefix or a combination that resembles this prefix, it will be excluded in the non-owner's final registration, unless the registered owner of the prefix may grant permission, in writing and on file with the Registry, to designated person(s) to allow use of the prefix.**
